TAXATION OF COSTS - REASONS

M. LAMY, TAXING OFFICER

This action was dismissed with costs on January 6, 1988 by the Honourable Mr. Justice Dubé, as was the plaintiff's appeal of that decision to the Federal Court of Appeal.

Alain Gareau accordingly submitted bills for the taxation of his costs at trial and on appeal on May 8, 1997. The plaintiff's representative was absent although duly served.

Under Tariff B, Column III, the defendant claims items 2 (5 units), 7 (3 units), 8 (3 units), 9 (1 unit/3 hours), 13(a) (3 units), 13(b) (2 units), 14(a) (2 units/9 hours) and 26 (3 units).

In light of the criteria set out in Rule 346(1.1), that of the volume of work in particular, the requested fees are allowed in their entirety with the exception of item 26. In my view, 2 units would be fair compensation, since the taxation of costs was uncontested and took place at the same time as the taxation of the costs of the appeal. The amount of \$3,900.00 is accordingly allowed

for fees. As for the costs of \$129.00 for photocopies, they are allowed, as they seem reasonable in the circumstances.

The costs of the defendant in the instant case are taxed and allowed in the amount of \$4,029.00. A certificate is issued in that amount.
