REASONS FOR JUDGMENT

PINARD J.

The appellant is appealing the citizenship judge's decision under paragraph 5(1)(e) of the Citizenship Act to dismiss his application for citizenship on the ground that he had inadequate knowledge of Canada and of the responsibilities and privileges of citizenship. This is an appeal de novo.

Whatever the appellant's knowledge may have been when he appeared before the citizenship judge, he demonstrated to me that he has since acquired greater knowledge of Canada and of the responsibilities and privileges of citizenship. Although that improved knowledge is not yet complete, I believe, like the amicus curiae, that it is adequate and that it accordingly meets the requirements of the Act.

The appeal will therefore be allowed.
